

OFFICIAL BRISTOL/OXFORD GREAT AMERICAN GIVEAWAY RULES

I am a homeowner and want to receive additional product or service information. I understand that by entering the information above, I confirm that I am over the age of 18 and I am giving my express permission for you to contact me in the future by means of mail, email or phone (at numbers listed) to provide product, consultation or service information. We pledge to respect the privacy of our customers and GIVEAWAY participants. The information provided will be securely stored by Winchester and/or Winchester dealers and not shared with any third party persons. *Grand, 1st and 2nd prizes include product and a standard installation.

1. **ENTRY:** Entries must be completed within the applicable Giveaway dates – 5/1/2020 through 4/30/2021 to be eligible. Eligible entries consist of those entries submitted by homeowners residing within active Bristol or Oxford dealer sales territories.
2. **SELECTION:** Winners will be selected from among all eligible entries in a random drawing. The manufacturer, Winchester Industries, will conduct drawing the month of 7/2021. All decisions relating to the sweepstakes program and winners are Winchester's and are final.
